The CAO(SG), ICAR-IIHR, Bengaluru welcomed the Pensioners and requested them to share their grievances if any.

Seventeen Pensioners attended the IIHR-Pensioners meeting. Twelve pensioners attended offline and five Pensioners attended online (zoom) meeting.

The discussion was mainly about the delay in reimbursement of medical bills, purchase of Generic Medicines and Cashless medical treatment for Pensioners at Recognised Hospitals.

The following discussion held:

- Dr. Jagan Mohan, IIHR, pensioner asked for revision of pay and the same was clarified in the meeting itself.
- In the last meeting, the question was raised for finding new hospitals which are ready to charge CGHS rates, No Hospital has accepted to charge at CGHS rates.
- 3. Dr. Mandakrantha Bhattacharya has clarified regarding using the Generic medicine, in last three months, no patient had any health issues.
- 4. Dr. S. Ganeshan has questioned that if particular medicine is not available in Janoushadi, whether he has to wait or he can purchase from outside. The same was clarified in the meeting.
- 5. Mr. Prasanna kumar, S/o of Late Bylanjanappa has submitted all the documents to include his sister as Dependent. It has been told that the case is under process.
- 6. Delay in processing of medical bills was raised by the pensioners and it was clarified that the delay was due to paucity of funds.

7. There were no pending grievances related to pension / family pension.
