Applications are invited from eligible candidates for filling up the following vacant posts of Subject Matter Specialist (T-6) in KVKs through inter-institutional transfer on permanent absorption basis at ICAR-IIHR, Bengaluru. The details of posts and eligibility criteria are given as under :

* Other conditions/Eligibility criteria as mentioned below :

1. Officials who were appointed at entry level post of Subject Matter Specialist (T-6) in the ICAR - KVK under (Category.III)
2. Educational Qualification : Essential : M.Sc (Soil Science & Agri.Chemistry) or M.Sc (Home Science) from a recognized University depending on the post under Sl.No.01 or 02 respectively.
3. Knowledge of local language to speak, read & write (Kannada).
4. The employees should have completed five years of service after their initial appointment on the date of notification of calling of application ie., 18th Feb 2020 except in cases where request is on medical/working spouse grounds (if applied on Medical /Working Spouse Grounds necessary certificate should be enclosed as per council's letter dated : 19.03.2020) and they should have completed probation and confirmed in the post.

The terms & conditions for Inter Institutional transfer shall be as laid down in the Council's letter F.No.TS-19(01)/2020/Estt.IV dated : 19.03.2020.

It is requested that the vacancies may please be circulated amongst the eligible candidates working at your Institute/Regional Stations who fulfils the requisite eligibility conditions to enable them to apply for the same on the proforma given overleaf . Applications of only such candidate(s) who can be relieved immediately in the event of their selection for the above posts may be forwarded along with the following documents within 30days from the date of issue of this circular :-

1. Initial appointment letter for the post of Subject Matter Specialist (T-6grade) issued by their respective Institutes.
2. APAR dossiers for the last five years
3. Vigilance Clearance Certificate and Integrity Certificate
4. A statement of major/minor penal, if any , imposed on the applicant during the last five years.
5. As the above mentioned posts are to be filled through candidates belonging to "Unreserved Category" while forwarding the applications of the candidates , the Head of Administration of the Institute may certify that the candidate was selected in that Institute against UR category-post of SMS without availing any relaxations meant for SC/ST/OBC candidates like relaxation in age, educational qualification, relaxation in qualifying marks etc., In the sense , even if the applicant belongs to SC/ST/OBC category, he/she should have got selected against UR category post of SMS (SS &AC) /SMS (Home Science) as if he/she is a UR Category candidate.

The application should be addressed to the Director, ICAR-Indian Institute of Horticultural Research, Hesaraghatta Lake Post, Bengaluru – 560089 .

The candidates initially appointed as Subject Matter Specialist(SMS) in ICAR administered KVK may send their application through proper channel in the enclosed proforma (as Annexure – I) . The last date of receipt of application is 10.06.2022 . Applications received after the last date or otherwise incomplete applications are not considered. The Selection Committee/the Director, ICAR-IIHR, Bengaluru shall reserve the right to accept/reject the application without assigning reason thereof.
