Terms & Conditions

1. The Tenderer shall quote basic value of equipment/machinery rates, GST, Freight charges if any, should be indicated separately.
2. The rates should be quoted as per the BOQ uploaded on the CPP Portal (reference may be obtained from Annexure-III). GST, if any, should be indicated separately. It must be noted that the contract shall be awarded to the firm which fulfils all the required terms and conditions and remains L-I for all the items put together.
3. The firm must also possess valid PAN No. & GST registration number and a copy of the same must also be enclosed with the tender document.
4. Copy of Financial year 2017-18, 2018-19 & 2019-20, Income Tax Statement may be furnished.
5. The firm should be in existence for over 05 (Five) years in the trade with the business turnover of not less than Rs.10 Crores per annum for 2017-18, 2018-19 & 2019-20. Chartered Accountant certified profit and Loss account, Balance sheet to this effect may be enclosed.
6. Modification in the tender documents after the closing date is not permissible.
7. The model offered by the tenderer if found out dated or manufacturing of the same is discontinued, then the tender will not be considered.

18. Bid Validity: 180 days

19. Our Institute is registered with DSIR and we are exempted from Excise Duty & Custom Duty. Hence CDEC/DSIR will be provided to the firm, if demanded. Rate should be quoted accordingly.

20. Payment:-

a. Payment for goods supplied from abroad

- i. On shipment 90% of the contract price (FOB) shall be paid through irrevocable letter of credit upon submission of documents detailed in L/C.
- ii. 10% of the contract price (FOB) (in foreign currency) and other charges like freight etc., from FOB to FOR, IIHR, Bangalore /(in INR) will be released after satisfactory installation/working of equipment/machine etc. As well as on submission/production of Performance Bank Guarantee by the Supplier(s).

b. Payment of goods supplied within India

21. Installation:- Within **20 days from the date of receipt of equipment** in the Institute, failing which Liquidated Damage clause shall apply.

Liquidated Damage clause: It would be realized @ 0.5% (half per cent) of the base price (excluding taxes) of the delayed goods for each week of delay subject to maximum 20%.

22. Prices:

- i. Price to be quoted in Foreign Currency CIP, Bengaluru Airport and to be delivered @ IIHR Hesaraghatta, Bangalore.
- ii. If any bidder wants to quote in INR, price be quoted on FOR, IIHR, Hesaraghatta, Bangalore basis.
- iii. In case the stores pertain to Import:
 - a) Kindly ensure to enclose manufacturer's authorization in favour of Indian subsidiary firm. It may also be noted that further authorization by subsidiary firm in favour of any other firm located in India to promote their sale must have authorization from the Principal firm for further authorization to an Indian firm, failing which the tender is liable to be cancelled.

INSTRUCTIONS FOR ONLINE BID SUBMISSION

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>.

REGISTRATION

- Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL <https://eprocure.gov.in/eprocure/app>.) by clicking on the link '**Online bidder Enrollment**' on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class II or Class III certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify/nCode/eMudhra etc.) with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder then logs in to the site through the secured log-in by entering their users ID/password and the password of the DSC/e-Token.

SEARCHING FOR TENDER DOCUMENTS

- There are various search options built in the CPP Portal. To facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. To search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.
- The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

PREPARATION OF BIDS

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in

which the bid documents have to be submitted, the number of documents- including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- To avoid the time and effort required I uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use 'My Space' or 'Other important Documents' area available to them to upload such documents. These documents may be directly submitted from the 'My Space' area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- Bidder should log into the site wll in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other technical issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidder has to select the payment option as 'offline' to pay the tender fee/EMD as applicable and enter details of the instrument.
- Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- Bidders are requested to note that they should necessarily submit their financial bids in the Format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cell with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. Technical Specification for Supply installation testing and commissioning of EA-LC-IRMS- 01 No.

1. Mass spectrometer

- Accelerating voltage $\geq 3,000$ volts, must be highly sensitive and highly linear.
- Absolute sensitivity of CO_2 (molecules/ion) must be equal to or better than 1200 in continuous flow mode. Source linearity must be better than 0.02%/nA for CO_2 . This must be supported by documentation.
- For hydrogen measurements H_3 +correction should be ≤ 8 ppm/nA.
- Internal precision 1σ (‰) for:
 $\delta^{13}\text{C}$ (CO_2): ≤ 0.06 ; $\delta^{18}\text{O}$ (CO_2): ≤ 0.08
- Source must be self-aligning and have a plug-in design and should be easily replaceable by user.
- Highly stable electromagnet for separation of masses.
- Filament inert to oxygen.
- Universal triple collector and collector for dD measurements; collector array should measure isotopic ratios of H, C, N, O and S in gases H_2 , CO_2 , N_2 , N_2O , SO_2 , O_2 and CO .
- Completely automatic inlet switching between inlets, viz. EA and LC.
- Data system for control of mass spectrometer, data acquisition, and data reduction. Instrument control software must have a library of routines which automate the measurement of the quantities that are measured in the final test of an instrument, including absolute and relative sensitivity; linearity, abundance sensitivity; magnet stability and high voltage power supply stability. Software must allow full access to all raw data and processed data, full access to ion correction algorithms and intermediate data, and full access to raw data integrity and sample identity.
- Vacuum pumps (Rotary and Turbomolecular pumps) and gauges should be provided for the vacuum necessary for isotopic measurements. Automatic system protection in case of power failure. Display of vacuum status on front panel of software.

2. Interfacing

- The interface of Elemental Analyzer to IRMS must have automated sample dilution, automated addition of reference gases.

3. Elemental analyzer

- The system must have two furnaces viz Combustion and Reduction furnace, so that it is possible to carry out isotopic analysis of bulk material for C, N, S by combustion.
- The furnaces should be able to achieve a temperature of 1100°C or higher.
- Autosampler for continuous analysis of > 120 samples, having Zero blank facility to ensure complete removal of atmospheric gases.
- Column temperature programming for separation of isotopes/elements in the same run.
- Precision should be guaranteed for all three isotopes in a single run. The external precision (1σ) should be

$\delta^{13}\text{C}$ (CO_2) 0.10 ‰, sample size 50 μg C

$\delta^{15}\text{N}$ (N_2) 0.15 ‰, sample size 50 μg N

$\delta^{34}\text{S}$ (SO_2) 0.20 ‰, sample size 50 μg S

This must be supported by documentation.

- All necessary software and hardware should be supplied as a standard part of the EA. EA should be capable of operating as a standalone unit for CNS elemental analysis.
- The provision for dilution of analyte gases should be there so that the measurement of highly abundant to trace elements can be performed. The continuous flow interface should be capable of delivering at least 5 or more reference gases such as CO_2 , N_2 , SO_2 , CO , H_2 simultaneously.
- Compatible software to use EA in stand-alone mode.

4. HPLC or LC-IRMS

- Automated HPLC-IRMS system for isotopic analysis of $^{13}\text{C}/^{12}\text{C}$ in compounds that are chromatographically resolved in HPLC column.
- Hardware options must include pump/temperature-controlled auto sampler/column oven/columns for IRMS sample analysis. It must have all necessary interfaces for the sample to convert into gaseous form/dilution of samples with minimum maintenance and highly reliable/reproducible oxidation technique to convert sample into CO_2 .
- Suitable interface to convert the sugars eluted from LC into CO_2 . The interface should ensure moisture free delivery of CO_2 to the IRMS.
- The interface should be free from crystallization due to usage of aggressive chemicals such as H_3PO_4 and $\text{Na}_2\text{S}_2\text{O}_8$ etc. (if used).
- User friendly software for the analysis and to control the interface.

- Acquisition of samples on LC-IRMS is preferably through one software only.
- All the calibration standards (for honey adulteration) required to calibrate the IRMS, along with all the peripherals, should be quoted separately
- The external precision should be:
 $\delta^{13}\text{C} (\text{CO}_2)$ 0.30 ‰ or better

Others

- Gas cylinders for CO₂ (Qty 2), Oxygen (Qty 2) and Helium (Qty 2) and associated parts (regulators, purifiers panels, tubings and plumbing etc) should also be provided.
- Analytical microbalance (Mettler Toledo Micro Balance WXTS3DU model or equivalent)
- Computer: Core i5 quad core, 8GB DDR4 RAM, 500GB HDD, Win 10, 24" LED Monitor, with 3 years onsite warranty, with a heavy-duty LaserJet printer.
- 15 KVA UPS is required for uninterrupted power supply for at least two hours back-up for mass spectrometers and associated peripherals.
- Ultrasonic bath with heating and degassing (Vol. 4.00 lit or above; US frequency 37 KHz or above; Branson Model CPXH or equivalent)
- Hot air oven (Temperature up to 250 °C; Vol. 55 litres or more, Venticell or equivalent)
- Water bath (12 litre or more, Grant or equivalent)
- Air conditioners (2 tonne capacity)- 2 Nos.
- Vendor should provide complete user list (including email id and phone numbers) and performance certificate of their IRMS systems.
- Quotations should include consumables for 6000 samples on EA-IRMS and 2000 samples on LC-IRMS. Maintenance kits for five years, solvent bottles (04 no, 1000mL capacity), solvent filters (glass/ss, 20 nos.), 05 extra LC columns for sugar analysis (as per standard honey testing method), 10000 sample vials, 02 solvent filtration kits with 2000 filters (47 mm, 0.47 μ), 10 sample filtration kits with 5000 filter (25 mm, 0.2 μ), automatic pipetter 02 each for 10 μ L, 100 μ L, 500 μ L, 1000 μ L with 1000 tips for each.
- Complete system should have one year warranty followed by four years of AMC from the date of satisfactory installation. Furnaces and detectors should have ten years warranty from the date of satisfactory installation. The annual maintenance contract plan should have at least two preventive maintenance visits, two break down visits, and technical support. Supplier should provide details of warranty and annual maintenance contract plan.

- Sufficient trainings to the satisfaction of customer should be provided during warranty period.
- All application details in the field of honey/allied items and food testing have to be provided during installation.
- Up gradation of all software installed along with the complete system, should be provided free of cost, as and when it is released, during the warranty and AMC period.
- The supplier shall keep inventory of spares and consumables in India that are normally required for the repair of equipment. Kindly submit the undertaking for the same.
- Vendor should be able to supply all the spares / consumable required for repair for at least 8-10 years after installation. Kindly submit the undertaking for the same.
- The bidder shall not submit the bid of any discontinued model. The quoted model of the equipment should be available in the original equipment manufacturer's website.
