**INSTRUCTIONS FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>.

**REGISTRATION**

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL <https://eprocure.gov.in/eprocure/app>.) by clicking on the link '**Online bidder Enrollment**' on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class II or Class III certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify/nCode/eMudhra etc.) with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder then logs in to the site through the secured log-in by entering their users ID/password and the password of the DSC/e-Token.

**SEARCHING FOR TENDER DOCUMENTS**

- There are various search options built in the CPP Portal. To facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. **PREPARATION OF BIDS**

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents- including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned

document.

- To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use 'My Space' or 'Other important Documents' area available to them to upload such documents. These documents may be directly submitted from the 'My Space' area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### SUBMISSION OF BIDS

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other technical issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidder has to select the payment option as 'offline' to pay the tender fee/EMD as applicable and enter details of the instrument.
- Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. Otherwise the uploaded bid will be rejected.
- Bidders are requested to note that they should necessarily submit their financial bids in the Format provided and no other format is acceptable. **TECHNICAL SPECIFICATION FOR SUPPLY OF ELECTRONIC COLOR SEED SEPARATOR WITH ACCESSORIES – 01 No. to ICAR-IIHR**

**Seed Color sorter and other accessories:**

**1. DUMP HOPPER FOR ELEVATOR:**

Dump Hopper must be made of Mild Steel with Powder Coating. Top of the dump hopper must be covered with heavy duty gratings, to restrict all coarse impurities into the hopper. Capacity: 0.15 Cu.mtr. Hopper to be made of M.S. Sheet not less than 1.5 mm thickness.

**2. BUCKET ELEVATOR**

1	Capacity	<b>Up to 2 TPH on Wheat Basis</b> To feed Seed Fine cleaner with one way discharge valve with feeding control lever. ## **6. ELECTRICAL CONTROL PANEL, CABLES AND ACCESSORIES**

It should be made of 14 SWG, MS sheet and should be dust and vermin proof with IP – 42 degrees at protection and must be treated in 7 tank process with powder coating. Make of switch, gears and cables – ABB/Schneider/CG/Finolex/L&T/ Siemens.

1. Change over cum MCC panel, CRCA powder coated with IP 42 degree protection.
  - a. The panel busbar should be Aluminum with heat shrinkable sleeves.
  - b. The panel should have one earthing busbar with termination facility at both sides.
  - c. The panel shall be of MS and Powder Coated.
  - d. The cable chamber and busbar chamber to be provided with bakelite sheets.
  - e. Centralized display panel showing position of plant equipments with LED Indicators (mimic).
  - f. MCCB (with magnetic and thermal release) with front door interlocked operating handle.
  - g. Motor feeder provided with MPCB and Contactor for better performance.
  - h. Vacuum impregnated control transformer for adequate VA burden for control circuit.
  - i. Change over switch from EB to DG (if necessary).
2. Power cables (Armoured Copper) for motors.
3. Control Cables (Armored Copper).
4. Earthing stations: 02 sets Complete with 300x300x3mm copper electrode, 32mm dia GI Pipe with funnel, Masonery chamber with C.I. cover of 30x30cms etc. complete with salt and charcoal. Earthing for plant equipments and panels.
5. GI Flat along Cable Tray.
6. GI wire from tray to individual motor.

7. Cable Terminations.
8. Junction Boxes (if necessary).
9. Cable Trays: GI Perforated.
10. Power and control cables –poly cab make.
11. Cable tray supports.
12. Field push button (if necessary).

**7. SPOUTS AND CHUTES:**

Elevator pit cover, diverting chutes, air ducting, electric cables, electric fittings, railing, stairs, supports, inspection window etc. wherever required to complete plant on turnkey basis shall be included for supply on turnkey basis. All Spouting pipe connections should be made with good quality materials, to avoid early damage due to high erosion of the seeds.

**8. RAISED STRUCTURAL PLATFORM WITH AC & CABIN:**

Raised platform structure for mounting Color Sorter and for the Cabin as per the suitable height. Made of heavy-duty MS channels, angle iron, clear height shall be 3.0 mtr from ground level. Complete with stair, railing & walking platform. The top sheet of the platform shall be non- slippery & easy cleaning type.
