The Director, IIHR, Hesaraghatta, Bengaluru on behalf of the Indian Council of Agricultural Research, Krishi Bhavan, New Delhi invites tender for disposal of 4 nos. trees above the ground level at Indian Institute of Horticultural Research ,Hesaraghatta , the details are as follows:

Persons who intend to participate in the tender may submit their tender to this office in the prescribed form.

TERMS AND CONDITIONS OF TENDER

1. The trees may be inspected on any of the working days between 9:00 am and 3:30 pm with the permission of the Nodal officer, Farm Management.
2. The tender should be submitted in the prescribed tender form obtainable from the office of I.I.H.R., Hesaraghatta on payment of **Rs. 100/-**
3. The earnest money of **Rs.1000-00** should be deposited in the form of Crossed Demand Draft obtained from any Nationalized bank drawn in favour of "The Director,IIHR, Hesaraghatta payable at SBI, Hesaraghatta by the bidder / tenderer to the AAO(SP), I.I.H.R, Hesaraghatta The bid/ tender will not be considered if the earnest money Demand Draft is NOT DEPOSITED ALONG WITH THE TENDER. No requisition for transfer of any previous deposit of earnest money will be entertained. The number and date of demand draft should be clearly indicated in Form No.1.
4. The tender form should have been obtained from the Officer inviting tender and the duly filled in tender form should be submitted within the stipulated time to the AAO (SP), IIHR, Hesaraghatta. Or Tender form down loaded from IIHR website at www.iihr.res.in No cash transactions for payment of EMD will be entertained.
5. The tenderer should furnish his full name and address.
6. The prices quoted in the tender for 4 nos. trees to be removed above the ground level should be mentioned clearly in the enclosed FORM-1, which is required to be submitted to this office along with earnest money D.D. The duplicate portion in Form-1 is to be retained by the tenderer.
7. The tender should be submitted in a sealed cover marked "TENDER FOR REMOVAL TREES the tender may be deposited in the box provided in the office or sent by post before due date.

8. Last date and time for receipt of tender is 2.00 P.M. on **21.07.2020**. at this office.
9. Time and date of opening of tender will be at **2:00 p.m on 22.07.2020**. at this office.
10. **OPENING OF TENDER:** Bidders / tenderers are at liberty to be present or authorize a representative to be present at the time of bid / opening of the tender with precaution and ensuring social distance for containment of COVID 19 at the time of opening of the sealed tender.
11. **MODE OF PAYMENT:** 100 % of the bid amount is to be paid in cash ^{or online payment} on the spot by the successful bidder .
12. **RIGHT OF ACCEPTANCE:** The IIHR in its absolute right may accept the highest bid or any tender and reserves to itself the right of accepting the whole or any part of the tender or portion of the rate quoted.
13. **ARBITRATION:** In the event of any dispute in this regard, the right of adjudication shall rest with the Director, Indian Institute of Horticultural Research, Bangalore and the final decision will be ultimate and binding on all parties.
14. The successful bidder should not sublease the tender and in the event of this office coming to know about the subleasing of the tender, the entire amount shall stand forfeited and as per rules, the next successful bidder will be officially awarded the tender.
15. The tenderer shall remove the trees only on working days during office working hours
16. The tenderer shall have no objections for the officials of this station to carry out the research activities/ farm operations of routine nature by this station including plant propagation.
17. The tenderer should abide by the changing rules and regulations of the tender.
18. The Director IIHR, reserve the right to accept or reject the tender without assigning any reason.
19. Except the EMD of the successful bidder, all the unsuccessful bidder's EMD received through crossed demand draft will be returned on the next day to the concerned after the process of bid / auction is completed.
20. **WATCH & WARD:** Watch and ward arrangements are required to be made by the successful bidder / tenderer immediately after the award and the station is not responsible for the theft and damage by natural calamities or by birds and animals or insect pests and diseases and no money will be refunded in such cases.
21. The removal of trees by the bidder / tenderer under the supervision of the farm staff by the bidders own labourers during working days. The name of such labourers engaged as watch and ward and for removing the trees must be provided to the office by the successful bidder without fail. No child labour shall be employed for any of the works.
22. The block(s) / areas included in the tender may or may not be irrigated during the whole period of tender.
23. The bidders/ tenderers violating any of the above terms and conditions would stand to forfeit the EMD /SD and the undersigned reserves the right to execute this. No complaints would be entertained in this regard.
24. **LAST DATE FOR COMPLETION OF work is 20 days from the date of tender opened.**
25. The bidders/ tenderers are requested to provide their complete address and phone nos. The tender with incomplete/false address/ phones may be rejected.
